REGULAR MEETING FOR BOARD OF TRUSTEES VILLAGE OF FAIRMONT, NEBRASKA MONDAY, MAY 13TH, 2024 AT 7:00 PM

The Village Board of Fairmont, Nebraska met in regular session on Monday, May 13th, 2024 at 7:01p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Notice of the meeting was given in advance according to proper notification by posting of meeting notice at Heartland Bank-Fairmont Branch, U.S. Post Office and Fairmont Village Hall. Chairman Don Moses called the meeting to order. Clerk/Treasurer Karen Margheim recorded the minutes. Board members present upon roll call were: Don Moses, Rod Ehmen, Victoria Verhage, Matt Hafer and Jack Slocum. Visitors to the meeting were: Eric Johnson, Steve Parr, Tyler Keenan, Mike Scheil, Stephanie Chambers, Tyler Salmon, and Shandra Reinsch. Chairman Moses noted that a copy of the Open Meetings Act was posted on the bulletin board in the council meeting room for public inspection and review. Ehmen moved and Hafer seconded to approve the minutes of the April 8th, 2024 Regular Meeting and May 1st, 2024 Special Meeting. Voting: 5 ayes, 0 nays. Motion passed. The Treasurer's Report for April 2024 was placed on file.

Fillmore County Development Corp. Update

Eric Johnson gave an update on FCDC program. Membership continues to increase over the past few years. There has been a total of 32 county applications for the housing grant program.

Water treatment plant bid award

A motion was made by Verhage, seconded by Ehmen to issue a notice of award for the water treatment plant project to Hackel Construction, Inc. for the amount of \$2,672,173.25. Roll call vote-5 ayes, 0 nays. Motion passed. Even though the bid was a little over the estimate the Village will still qualify for a 75% grant towards the total cost of the project. The Village will be responsible for the \$668,043.31 remaining balance after the grant.

One- & Six-Year Road Plan

Steve Parr was present to discuss the One- & Six-Year Road Plan. The Road Plan gets reviewed annually in order for the Village to receive highway allocation funds monthly. There are currently two projects being looked at for the one-year plan. They are on E and F Streets starting from 6th Ave. and ending at 9th Ave. This will include either asphalt milling and patchwork for an approximate cost of \$240,000. Paving this area was also discussed with an exact estimate not known at this time. There are eight various projects listed on the 6-Year Road Plan.

Lot Split Application

A motion was made by Ehmen, seconded by Slocum to approve the lot split application for lots in the 800 block of 8^{th} Ave. Roll call vote -5 ayes, 0 nays. Motion passed.

Health Insurance Renewal

A motion was made by Hafer, seconded by Verhage to approve the health insurance renewal plan with Blue Cross/Blue Shield of Nebraska available to full-time employees. Roll call vote -5 ayes, 0 nays. Motion passed.

Water Rate Study

After reviewing our current water rates and upcoming expenses and current income, it was decided to have a water rate study completed. In order for the Water Fund to sustain itself, there will need to be an increase in water rates. A motion was made by Verhage, seconded by Ehmen to increase the base rate by 11.50 and usage 11/100 gallons used in a 2-step process with new rates going into effect in October 2024 for the first half of the increase and October 2025 for the second half of the increase. Roll call vote -5 ayes, 0 nays. Motion passed.

PFAS Testing and Agreement

After some discussion, it was decided the Village would not complete the reimbursement agreement for PFA's Testing.

Claims

A motion was made by Hafer, seconded by Slocum to approve claims as they were presented to the board. Roll call vote – 5 ayes, 0 nays. Motion passed.

Library Report-Stephanie Chambers

Utility Superintendent Report – Mike Scheil

Mike shared the pool projects being completed before the swim season. The updates on the water tower by Verizon have been completed. There was a discussion on installing a weed sprayer on the side-by-side. More gravel will be ordered for the streets.

Village Marshal Report – Tyler Salmon

A nuisance property discussion ensued followed by dialog regarding unlicensed vehicles.

Clerk/Treasurer Report-Karen Margheim

The clerk shared a couple of upcoming meeting dates and the Municipal Accounting and Finance Conference held in Lincoln on June 12th-June 14th. A packet of information was received regarding the TextMyGov communication program. There is an expense to use this program but isn't justifiable at this point.
