The Village Board of Fairmont, Nebraska met in regular session on Monday, December 9th, 2024 at 7:00p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Notice of the meeting was given in advance according to proper notification by posting of meeting notice at Heartland Bank-Fairmont Branch, U.S. Post Office and Fairmont Village Hall. Chairman Don Moses called the meeting to order. Clerk/Treasurer Karen Margheim recorded the minutes. Electric Rate Study Agreement

After some discussion regarding the increase in cost of power purchased and the cost of an electric rate study (from two separate companies), it was decided to wait until the cost of the study can be included in the next fiscal year budget.

Correspondence

Three separate items were included in correspondence for review. The first included a letter from NPAIT (Nebraska Public Agency Investment Trust) of Nebraska regarding the option for investment of funds. The second item was a letter from NMPP Energy giving official notice of modification and termination of the agreement for EDS (Electric Distribution Services). NMPP Energy will still be available for services when needed, but will save the Village \$2,000/year by not continuing the agreement. The third and final letter was from EMC Insurance regarding changes in coverage due to a roof that is more than 15 years old.

Library Report-Stephanie Chambers

Stephanie will be completing the annual survey due for the library. In March, Fairmont will be hosting the area-wide monthly meeting for the local libraries.

Village Marshal Report – Tyler Salmon

There was no report given.

Utility Superintendent Report – Mike Scheil

Mike shared his monthly report with the board members prior to the start of the meeting. A load of aluminum and copper was sold to Fehlhafer's Inc. in Utica for just under \$3,000.00. There was a discussion on purchasing a snowblower for the skid steer and installing a snow fence north of A Street.

Aging Services-Shandra Reinsch

The monthly foot clinic has seen a growth in the number of participants. Shandra discussed her plans to increase the awareness of services and food provided by the Senior Center with the use of various advertising options. A couple of organizations also made donations to the Senior Center this past month.
